Venue: The Washington Gallery of Photography is located in downtown Bethesda, Maryland. With hundreds of visitors at each opening, patrons will view your work in an upscale, well-lit venue.

Prizes: Cash prizes will be awarded to First, Second, and Third place winners.

Entry Requirements: Open to residents of any state, territory, and DC. Pieces must showcase the theme of the show. Any two or three-dimensional artwork is eligible: Fibers, Painting and Drawing, Sculpture, Print Media, Photography, etc. Dimensions of framed work must be less than 48 in. by 48 in.

Entries: All artwork will be judged from slides or jpegs on CD. Send copies, not originals.

Submission Guidelines: Mark each entry with your name/phone number. Number entries to correspond to the entry form.

Slides: 35mm only, no glass. Slides must be labeled on the front, mark the top with an arrow.

CDs: CDs must be labeled on the case and the disk with your name and phone number. CDs must contain low-resolution (72 dpi by ~600 pixels in the longest dim) jpegs only, named with the title of each piece.

Form: Complete the attached form. Include the number, title, medium, and size of each piece.

Include a SASE for return of your submission.

Photocopies of this form are acceptable. Use additional sheets if more than four entries are submitted.

Fee: The entry fee is **\$30 for 4 entries**. Additional entries are \$5/each. Enclose a check or money order for the total fee payable to **Capitol Arts Network**.

Send your entry to Capitol Arts Network, PO Box 7541, Gaithersburg, MD 20898. The deadline is **April 28, 2009**.

All due care will be taken with your submission, but Capitol Arts Network is not responsible for damage or loss.

Accepted Work: Notification of acceptance will be posted on the CAN website (www.CapitolArtsNetwork.com) by **May 7, 2009**. Two dimensional work must be framed and wired, ready for hanging. Delivery/return is the artists' responsibility. Detailed shipping instructions will be provided online with the acceptance notification. Capitol Arts Network reserves the right to not show a piece or artwork that has below standard presentation, such as scratches, dust, or poor workmanship.
